DECLARATION OF J. GERARD STRANCH, IV IN SUPPORT OF MOTION FOR ATTORNEYS' FEES, EXPENSES, AND CLASS REPRESENTATIVE SERVICE AWARD

- I, J. Gerard Stranch, IV, am over the age of eighteen years. I offer this declaration in my capacity as one of the attorneys for Class Representative, Payshence Carr ("Class Representative" or "Ms. Carr"), individually, and on behalf of all others similarly situated, in the above styled action, in support of the Motion for Attorneys' Fees, Expenses, and Class Representative Service Award. I have personal knowledge of the facts recited in this declaration, and if called upon to testify to the truth of the statements below, I could and would do so:
- 1. I am a licensed attorney in private practice in the state of Tennessee. The law firm I work for is Stranch, Jennings & Garvey, PLLC, in the capacity of Managing Partner.
- 2. The Court has appointed me and my firm, Stranch, Jennings & Garvey, PLLC, as well as Cohen & Malad, LLP, The Johnson Firm, and Hellmuth & Johnson, PLLC as Class Counsel. Preliminary Approval Order, July 18, 2023, ¶ 3.

3. The firms comprising Class Counsel have reported expenses in prosecuting this action of \$8,348.43 as itemized below:

- 4. These expenses were reasonable and necessary to this litigation and are the type of costs normally charged to a paying client, so they are reimbursable.
- 5. Pursuant to the Settlement, SCHA will pay all costs and expenses of settlement notice and administration, including, but not limited to, the expense of the Settlement Administrator, the expense of preparing the Class Member List, and all expenses involved in providing notice to the members of the Settlement Class and distributing the benefits of the settlement to Class Members, not to exceed \$200,000.00, out of the Fee and Expense Fund. Settlement Agreement. ¶ 4.3.

- 6. The Settlement Administrator in this case, Kroll, has proposed and estimated the costs of administration at approximately \$66,600.00.
- 7. Deducting from the \$200,000.00 Fee and Expense Fund the \$66,600.00 for costs of settlement notice and administration, deducting the expenses of \$8,348.43 and deducting the Service Award of \$1,500.00 leaves the net amount for attorneys' fees of \$123,551.57.
- 8. Class Counsel estimates the value of the settlement, not including the costs of notice and administration, to be approximately \$500,000.00, which is comprised of the amount available for economic losses (\$300,000), plus the fees and expenses, costs of notice and administration and service award (\$200,000). The requested fee is therefore 24.71% of the value of the recovery.
